

1	Prayers	Mrs. E Nightingale opened the meeting with a prayer.	
	Apologies	Apologies were received from Mrs. C Reynolds and Mrs. H Sheridan. Apologies were accepted.	
	Declaration of Business Interests	A declaration of business interest was declared by Mrs. Clarricoats and Miss Turnbull regarding financial matters.	
2	Staff presentations on results from last academic year	The teachers presented a summary of the results from the last academic year for each stage of pupils. Miss Kellock presented KS2:	
		The results of Maths, Reading, Writing and SPAG were discussed. EH asked for clarity of how the marks were calculated for the 8 pupils. Miss Kellock explained the terminology regarding greater depth and the average scaled score.	



Miss Kellock then presented the predicted outcomes for 2017/18. English is currently a strong area and Maths slightly weaker although still above the National expectation.

The outcome from calculating progress and looking at structure /focus – is that a booster maths class is running in class 4 to aid the lower ability children to reach their targets and to help children aim and reach the expected level where possible. Additional time within the school day will be given to support those children who are targeted to reach greater depth.

Governors asked the question - 'Is the significant intervention given to aid pupils to pass exams or is it to prepare them for secondary?'

The HT and KS2 teacher explained that the aim is to do both.

Much debate and discussion followed regarding the questions.

All governors thanked Miss Kellock for the presentation.

Mrs. Reed presented Early Years

An analysis of the EY data was presented.

Question – EH Questioned the results for summer born children?

Mrs Reed noted that some children who did not get the GLD (Good Level of Development) were summer born children and of these children 2/3 only attended the school nursery for 1 day per week and did not attend any other nursery. Support is in place for these children moving forward into year 1, in the form of 1-1 phonics booster sessions. 2/3 children now have individual education plans.

All children progressed but 2 still require support.

Mrs Reed also discussed the target for the current Yr. R for 2018.

All governors were happy with the update and thanked Mrs. Reid for the presentation

Mrs. Clarricoats presented Year 1 Phonics Check Data:

Data for the Year 1 phonics check data was presented. 10 out of 11 passed the phonics screening check. Lanercost is one of the top 30 schools in Cumbria for it's Yr. 1 data in 2017. It was explained that the average score for the school was 37.5 out of 40 (32 being the pass mark). The one child who did not pass came to the school with no education prior to starting year 1, she will pass the check in Yr. 2

The target for 2018 is 10 out of 11, 91%.

All governors discussed the data and were happy with

the report

Thanks was expressed to Mrs Siddall for her contribution to the work completed.

Mrs. Clarricoats was thanked for her report.

Miss K Turnbull presented KS1:

The results were discussed at length due to these results being atypical for the school, slightly below both National and Cumbrian averages. The high percentage of SEN children within the cohort 3/7 was discussed and the progress of these children was explained.. 3 children in this cohort have an IEP. Although results were below national average, they were in line with teacher assessments and all children have personalized targets.

LD asked do you use different teaching tools and strategies if the children are not responding to a certain methods of teaching?

Miss Turnbull reassured the Governors that a variety of different strategies are available and each child is currently responding and making value added progress. This information is held in the IEP's and available for inspection. Mrs. Clarricoats explained the different interventions that the school currently provides and that staff research additional support strategies form the internet.

Question - What is the purpose of case studies?

It was explained that the case studies provide information in one place as to the interventions and additional support children receive and a tracker to check the progress being made by each individual.

Miss Turnbull was thanked for her report.
